

# Intercession and the Sovereignty of God

## 1. Conceptual Framework: Sovereignty and Prayer

### Key Doctrinal Pillars:

- **Immutability of God:** Malachi 3:6; Hebrews 13:8
- **Divine Omniscience and Omnipotence:** Isaiah 46:9-10; Psalm 115:3
- **Human Responsibility in Prayer:** James 5:16; Ezekiel 22:30

- **Ecclesiastical:** Corporate intercession within the church body
- **Societal/National:** Prayers for leaders, justice, and national repentance (cf. 1 Timothy 2:1)

### A. Abraham – Genesis 18:16–33

- Christ's high priestly ministry includes perpetual intercession.
- Our intercession is modeled after and empowered by His.

### 1. **Alignment with Divine Will:**

- Romans 8:26-27: The Spirit guides prayer according to God's purposes.

### 2. **Sanctification of the Intercessor:**

- Galatians 6:2: Encourages empathy and spiritual growth.

### 3. **Instrument of Divine Mercy:**

- 2 Chronicles 7:14: National healing conditioned on intercessory repentance.

### 4. **Transformation of the Intercessor:**

- Prayer recalibrates desires and priorities toward godliness.

- **Identification:** Seek divine guidance to discern intercessory targets (individuals, groups, issues).
- **Scriptural Foundation:** Utilize passages such as Ephesians 1:17-19 to structure intercessory content.
- **Persistence:** Emulate the persistent widow (Luke 18:1-8).
- **Track:** Maintain a prayer journal to track petitions and providential outcomes.
- **Join With Other Believers:** Develop or participate in an intercessory prayer group.
